Information for the applicant.

Licence and Grading Record Books and Insurance.

You must receive the Licence and grading record book within 6 weeks of application. The licence fee includes Insurance. Ask to see the Schedule of insurance. If you wish to make a claim under the BTCB Accident and Public Liability Insurance Policy you must notify the Membership Services in writing with 14 days of the accident occurring.

Failure to do so may result in claim rejection.

Medical Disorders.

Applicants who suffer from any medical disorder must attach to this form a letter from their doctor confirming that they are fit to practise Tae kwon do.

Failure to do so may invalidate insurance cover

Kup Examinations.

Kup (10th to 1st Kup) grading examinations can only be conducted by a 4th Dan or Higher grade. All successful candidates must be given an ETU certificate within 4 weeks of the examination.

Dan Examinations.

Full BTCB members resident in the UK are required to take their Dan promotion test at a sanctioned BTCB grading. BTCB Member Groups members resident in the UK are required to take Dan promotion tests at a sanctioned Members Group Dan Grading. BTCB Licence holders may not grade at any other Dan Promotion test within the UK without obtaining the permission of the BTCB National Executive in writing. The BTCB will not recognise the new grade of members who take any other Dan Promotion test when they are at the same time in membership of the BTCB. The member concerned may have His/Her licence revoked.

BTCB members resident overseas for more than one year must notify the National Executive of their intention to grade in their new resident country.
